4. Pay shall not be drawn until and unless a certificate issued by this office that their documents are verified by the institutes/Boards/Universities concerned.
5. They should join their posts within 15 days of the issue of this notification. In case of failure to join the post within 15 days of the issue of this Notification their appointment shall stand expired automatically and no subsequent appeal etc. shall be entertained.
6. Health & Age Certificate should be produced from the Medical Superintendent before taking over charge.
7. They will be governed by such Rules and Regulations as may be issued from time to time by the Government.
8. Their services shall be terminated at any time, in case his performance is found unsatisfactory during his service period. In case of misconduct, he shall be proceeded under the relevant rules & regulations announced from time to time.
