Subject: COMPULSORY ATTENDANCE OF MASTER TRAINERS, FACILITATOR/ SUBJECT EXPERTS FOR ALL TRAININGS

Dear All

I am directed to refer to subject cited above and to state that in pursuance of commitment for improving quality of education in KP, the Department of Elementary and Secondary Education has introduced the following training programmes.

1. Induction Training (For all districts)
2. CPD (Continuing Professional Development) Training (Peshawar, Charsadda, Swat, Buner, Haripur, Kohistan, Karak and DI Khan)
3. British Council English Language Training for Primary School teachers (All Districts)
4. Jolly Phonic Training (Mardan, Abbotabad, Lower Dir)
5. Nazira Quran Training (all Districts)
6. Assessment Training

RITE and DCTE are using the services of High and Higher Secondary School Teachers to work as Master Trainers, Facilitators (in the case of CPD) and Subject Experts (in the case of Induction Programme). All these programmes are compulsory for those who are nominated for these training as Master Trainers, Facilitators and Subject Experts and they are required to conduct these programmes offered by PITE from time to time.

All the DEOs are required to ensure attendance of teachers in all the training sessions. DEOs are further directed to adhere to the nomination criteria prescribed by PITE and not to send any substitutions without the prior approval of Director ESE.

You are further directed to inform all Head Masters/Principals and Head Mistresses that all these trainings are mandatory. No teacher and an official of the department of education can refuse to attend these trainings in their respective capacity either as a master trainer/facilitator/subject expert or as a participant.
