Terms & Conditions

1. No TA/DA is allowed.
2. Charge reports should be submitted to all concerned.
3. Appointment is purely on temporary, ad hoc and school based for a period of one year with effect from 01.03.2019 to 28.02.2020 which is extendable as per the policy of the provincial Govt.
4. Appointment is subject to the condition that the certificates/documents must be verified from the concerned authorities, anyone found producing bogus certificate/s or degree/s, his appointment shall be cancelled and he will be reported to the Law enforcing agencies for further legal action.
5. Pay shall not be drawn until and unless a certificate issued by this office that their documents are verified by the institutes/Boards/Universities concerned.

They should join their posts within 15 days of the issue of this notification. In case of failure to join the post within 15 days of the issue of this Notification their appointment shall stand expired automatically and no subsequent appeal etc. shall be entertained.

7. Health & Age Certificate should be produced from the Medical Superintendent before taking over charge.
8. They will be governed by such Rules and Regulations as may be issued from time to time by the Government.
9. Their services shall be terminated at any time, in case his performance is found unsatisfactory during his service period. In case of misconduct, he shall be proceeded under the relevant rules & regulations announced from time to time.
10. Their appointment is Ad hoc and school based. They will have to serve at the place of posting and their services are not transferable to any other station.
11. Their appointment is subject to the condition that they are domiciled in District Swat.
12. Errors and omissions accepted as a notice only.
13. Their salary will be drawn after winter vacation i.e 1/3/2019.
