## TERMS & CONDITION

1. No TA/DA is allowed.

2. Charge reports should be submitted to all concerned in duplicate.

3. Appointment is purely on temporary & contract/adhoc basis initially for one year with effect from 10-12-2018 to 09-12-2019.

He should join his post within 15 days of the issuance of this order, in case of failure to join the post within 15 days issuance of this order his appointment will expire automatically and not subsequent appeal e.t.c shall be entertained.

- 5. He should not be handed over charge if his age is exceeds 38 years and below 18 year.
- 6. Appointment is subject to the condition that the certificate/documents must be verified from the concerned authorities, anyone found producing bogus certificate will be reported to the law enforcing agencies for further action.
- 7. His services are liable to termination on one month's notice from either side. In case of resignation without notice his one-month pay/allowances shall be forfeited to the Government.
- 8. His Pay will not be drawn until and unless a certificate to the effect is issued by this office that his certificate are verified.
- 9. Health and Age certificate should be produced from the Medical Superintendent concerned before taking over charge.
- 10. Before handing over charge he will sign an agreement with the department, otherwise this order will not be valid.
- 11. He will be governed by such rules and regulation as may be issued from time to time by the Govt.
- 12. His services shall be terminated at any time. In case her performance is found unsatisfactory during his contract period. In case of misconduct. He shall be proceeded under the rules framed from time to time.
- 13. His appointment is made on school based, he will have to serve at the place of posting, and his service is not transferable to any other station.
- 14. Before handing over charge once again their document may be checked if they have not the required qualification they may not be handed over charge.
- 15. The appointees shall take nine (09) month mandatory training at PITE or RITE.
- 16. Their salaries will be release after winter vacation i.e. 01-03-2019.
